

FCPA Filing Calendar – HD42 Special Election Cycle

<p>Purple lines indicate deadlines involving monthly reports. Monthly reports are due on the second business day of the subsequent month beginning 12 months before the election date and after crossing the threshold which is \$1000. [17-5- 8(a)(1)] Monthly reports are not due if filing weekly reports. [17-5-8(k)]</p>
<p>Blue lines indicate deadlines involving weekly reports. Weekly reports covering the period Saturday through Friday are due on the Monday of the subsequent week beginning four weeks before the election date. [17-5-8(a)(2)] The last weekly report is not due if filing daily reports. [17-5-8(k)]</p>
<p>Red lines indicate deadlines involving daily reports. Beginning on the 8th day prior to the election, daily reports are due for principal campaign committees and PACs that receive or spend \$5,000 or more on that day with a view toward influencing the election. Daily reports are only due on those days that the \$5,000 threshold is met. Daily reports apply <u>only</u> to legislative, state school board, and statewide candidates, <u>not</u> circuit, district, county, or city candidates. [17-5-8(a)(3)(a)]</p>
<p>Principal campaign committees and PACs must file a report disclosing the receipt of any single contribution of \$20,000 or more within two (2) business days of receiving the contribution <u>if</u> the contribution has not already been reported in a finance disclosure report. [17-5-8.1(c)]</p>
<p>Green lines indicate the legislative blackout beginning and ending dates. The FCPA prohibits candidates for legislative and statewide offices from raising money while the Alabama Legislature is in session, except within 120 days of a primary, primary runoff, or general election. [17-5-7(b)(2)]</p>
<p>Electioneering communication is defined as any communication disseminated through any federally regulated broadcast media, any mailing, or the distribution, electronic communication, phone bank, or publication containing (1) the name or image of a candidate; (2) is made within 120 days of an election in which the candidate will appear on the ballot; (3) the only reasonable conclusion to be drawn from the presentation and content of the communication is that it is intended to influence the outcome of an election; and (4) entails an expenditure in excess of one thousand dollars (\$1,000). [17-5- 2(a)(5)]</p>

<p>Candidates intending to participate in the House District 42 primary election may not begin soliciting or accepting contributions until June 10, 2019. Candidates may loan funds to their campaigns prior to June 10, 2019.</p>
