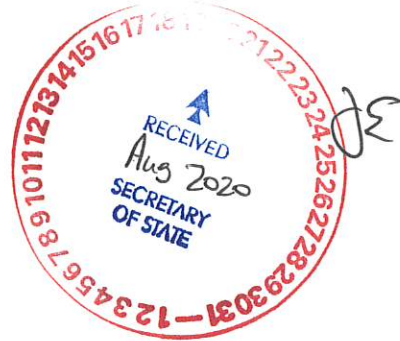


CERTIFICATION
