Dear Director Lane:

The Office of the Secretary of State notified the Libertarian Party of Alabama on May 25, 2022 that the party obtained ballot access for the 2022 General Election (see enclosure A).

Also, on May 25, 2022, my office notified the Alabama Ethics Commission of your ballot access, and we provided to the Ethics Commission a listing of the qualified candidates certified to us by the Libertarian Party of Alabama (see enclosure B).

As you were previously notified by my staff, each qualified candidate for non-federal office must comply with Sections 36-25-14(a)(3) and 36-25-15(a), Code of Alabama, 1975, regarding the filing of the Statement of Economic Interests with the Ethics Commission in order to be included on the ballot.

On June 1, 2022, the Ethics Commission provided my office with a listing of Libertarian Party of Alabama non-federal candidates that had, and had not, met the requirement to file a Statement of Economic Interests within the required time frame according to state law (enclosures C and D). Please accept this letter as notification that only the non-federal candidates listed in enclosure C will be certified by my office on August 26, 2022 to appear on the 2022 General Election Ballot to be held on November 8, 2022.

The Elections Division staff has completed the process of verifying signatures on your petition for ballot access as a statewide minor political party.

To be certified as a minor party by the Alabama Secretary of State for the general election, Code of Alabama 1975, section 17-9-3 (a) (3), requires that a minor party must file a petition containing signatures equaling or exceeding at least three percent of the qualified electors who cast ballots for the Office of Governor in the last general election in the county, district, or other political subdivision for which the minor party is seeking ballot access.

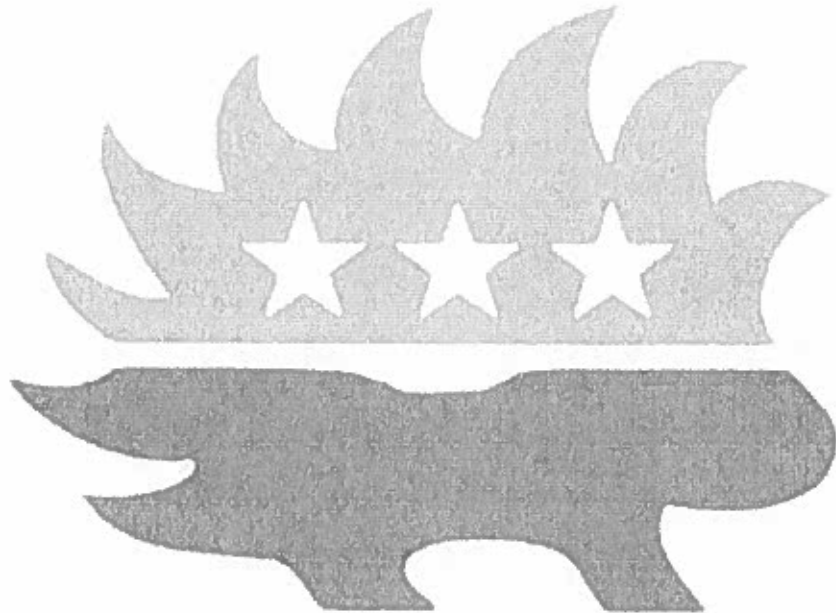
