The Democratic Party certified Tiara Young Hudson for Circuit Court Judge, 10th Judicial Circuit, Place 14 with an asterisk stating that the court seat is currently in litigation. The 10th Judicial Circuit, Place 14 has officially been moved from Jefferson County to Madison County, and an appointment was made by Governor Ivey for this seat. Therefore, the seat for Circuit Court Judge, 10th Judicial Circuit, Place 14 shall not be placed on the ballot for the 2022 General Election.


AMENDED CERTIFICATION
