**PROPOSED STATEWIDE AMENDMENT NUMBER ONE**

Proposing an amendment to the Constitution of Alabama of 1901, to change the name of the State Board of Education to the Alabama Commission on Education and to appoint the members of the commission by the Governor, subject to confirmation by the Senate; to change the name of the State Superintendent of Education to the Secretary of Elementary and Secondary Education; to appoint the secretary of the commission by the Governor, subject to confirmation by the Senate; and to authorize the Governor to appoint a team of local educators and other officials to advise the commission on matters relating to the functioning and improvement of the State Department of Education. (Proposed by Act 2019-345)
