PROPOSED STATEWIDE AMENDMENT NUMBER ONE Proposing an amendment to the Constitution of Alabama of 1901, to amend Article I, Section 1, to read: "The Alabama State Commission on Elementary and Secondary Education; to provide for the appointment of the members of the commission by the Governor, subject to confirmation by the State Superintendent of Education to the Secretary of Elementary and Secondary Education; to provide for the appointment of the secretary by the Governor, subject to confirmation by the State Superintendent of Education; to authorize the Governor to appoint a team of local educators and other officials to advise the commission on matters relating to the functioning and duties of the State Department of Education."
