Proposing an amendment to the Constitution of Alabama to amend Article IV, Section 103, of the Constitution of Alabama to provide for the appointment of the Secretary of Elementary and Secondary Education; to provide for the appointment of the members of the commission by the Governor, subject to confirmation by the Senate; and to authorize the Governor to appoint and remove the members of the commission on matters relating to the functioning and duties of the State Department of Education. (Proposed by Act 2019-345)
