<b>PROPOSED STATEWIDE AMENDMENT NUMBER ONE</b> Proposing an amendment to the Constitution of Alabama to read: "The name of the Alabama State Board of Education shall be changed to the Alabama Commission on Elementary and Secondary Education; to provide for the appointment of the members of the commission by the Governor, subject to confirmation by the Senate, in and to the name of the State Superintendent of Education to the Secretary of Elementary and Secondary Education; to provide for the appointment of the secretary by the commission, subject to confirmation by the Senate, in and to the name of the Governor, and to a team of local educators and other officials to advise the commission on matters relating to the functioning and duties of the State Department of Education.
