Once a principal campaign committee or PAC meets this daily amount, it must file daily reports up until the election date. Daily reports can be faxed to the Secretary of State's office at (334) 353-2295. Daily reports do not apply to elections involving county and city offices.

Principal campaign committees and PACs must file a report disclosing the receipt of any single contribution of \$20,000 or more within two (2) business days of receiving the contribution if the contribution has not already been reported in a finance disclosure report.
